









# Governance of BIODEV2030 project in Uganda

### **Body 1: BIODEV2030 PROJECT STEERING COMMITTEE**

#### Description and role:

WWF Uganda with support from Expertise France through WWF France is implementing the BIODEV2030 project in collaboration with government ministries and agencies, civil society organizations, academic institutions and the private sector.

To ensure successful collaborations and implementation of project activities, a project steering committee was created consisting of persons nominated by the stakeholder organizations/partners. The roles and responsibilities of the committee include:

- i) Monitor the progress of the project
- ii) Provide technical guidance on strategic matters.
- iii) Ensure and relay advocacy issues related to the project.
- iv) Participate in reviewing and validating terms of reference for research consultancy works described in the project activity plan.
- v) Participate in the evaluation of proposals submitted by consultancy companies/firms.
- vi) Recommend consultants for the in-depth studies and other various services.
- vii) Review and make input into draft research reports submitted by consultants.
- viii) Participate in BIODEV2030 engagements locally and internationally.
- ix) Participate in planning and implementation of activities such as ministerial and multi stakeholder meetings
- x) Reviewing draft proposals related to BIODEV2030.

The committee is chaired by Uganda's CBD focal point person who also works with National Environment Management Authority. The Faculty of Natural Sciences at Makerere University is the alternate chairperson of the committee.

### Description and role:
